1. Contribute to the activities of Identification, authentication and curation of cultures received at repository of AMR organisms and develop research activities in this domain.

General information and conditions:-

1. Application in the prescribed format* duly filled in along with Demand Draft and self-attested photocopies of all certificates showing date of birth, qualifications, details of examinations passed, experience, list of publications, patents, caste certificate, payment proof of application fee if any, recent passport size photograph and other relevant documents should reach to the Director, National Centre for Cell Science, NCCS Complex, S. P. Pune University Campus, Ganeshkhind, Pune – 411 007, Maharashtra, India. The last date for receipt of applications is 30 days from the date of publication of advertisement in Employment News. For candidates residing in North-Eastern States, Union Territory of Ladakh, Lahaul and Spiti Districts of Himachal Pradesh, Pangi Sub-division of Chamba district of Himachal Pradesh, Andaman & Nicobar Islands and Lakshadweep Island is 45 days from the date of publication of advertisement in Employment News. The name of the post applied for should be super scribed on the envelope.
2. The above posts are as per the Central Government pay scales and carry allowances like Dearness Allowance, Transport Allowance and HRA as per 7th CPC rules. However no NPA will be admissible for these posts.
3. Reservations as per the Government of India norms in respect of SC/ST/OBC/PWD etc. will apply. Age relaxation will be available to SC/ST/PWD candidates as per Government of India rules. SC/ST candidates should produce proof of their caste certificate from appropriate authority.
4. Age limits shall be reckoned as on the closing date for receipt of application. However, in case of exceptionally well qualified candidates the upper age limit may be relaxed by the Competent Authority.
5. The upper age limit is however, relaxable up to 05 years for SC/ST and 03 years of OBC as per the Government orders in force only in those cases where the posts are reserved for respective categories, on production of relevant certificates in the prescribed format signed by the specified authority at the time of interview. The OBC candidates should produce the prescribed certificate valid for employment under Central Government.
6. Applications received after due date and incomplete applications without required documents will not be considered.
7. 8. Candidates working in Government Departments/Public Sector Undertakings/Autonomous Bodies should forward their applications through proper channel.
9. Outstation SC/ST candidates who are called for interview will only be paid second class train fare from the actual place of undertaking the journey or from the normal place of residence whichever is nearer to Pune railway station on production of relevant document of travel. However, reservation and sleeper charges and surcharge on superfast trains will be admitted if requisite ticket/receipt etc. is submitted as proof of having actually incurred the expenses. In the absence of valid details in the TA claim, the surcharges, etc. will not be allowed.
10. All applicants must fulfill the requirements of the post and other conditions stipulated in the advertisement as on last date of the receipt of application. They are advised to satisfy themselves before applying that they possess the qualifications laid down for various posts as on the last date of receipt of the application. No enquiry asking for advice as to eligibility will be entertained. The prescribed qualifications are the minimum and mere possession of the same does not entitle candidates to be shortlisted for interview. The duly constituted screening committee may adopt its own criteria for shortlisting the candidates, based on number of applications received and functional requirements of the Institute. Decision of the Director, NCCS in this regard will be final and no correspondence or personal enquires will be entertained by NCCS on this behalf. The candidates should therefore, mention in the application all the qualifications and experience in the relevant area over and above the prescribed qualifications. The period of experience in a discipline/area of work, wherever prescribed, shall be counted after the date of acquiring the minimum educational qualifications prescribed for that post.
