- 8) The joining formalities will be completed only after in-person verification of the original documents. Failure to produce the original documents for verification will result in cancellation of the offer of appointment.

The duration of offer will be determined based on fund availability.

Other important Points:

1. The Director, NCCS reserves the right to cancel the recruitment process, if required.
2. **The prescribed educational essential qualifications and experience are the bare minimum and mere possession of same does not entitle candidates to be called for the Interviews. The Centre reserves the right to call for Interviews only those candidates who in its opinion are likely to be suitable.**
3. Candidates not having Final / Provisional Degree certificate as per the Essential qualification signed by the Institutional/ University Competent authority are not eligible to apply and such applications will be summarily rejected.
4. The above advertised positions are filled up purely on temporary basis for the limited time on the extramural projects funded by various funding agencies. The position will

automatically co-terminus on the completion of the candidate's tenure. The appointed person shall have no claim of appointment/absorption in funding agency or in NCCS, Pune.
